## shipping & delivery

We're happy to send your job via local courier, U.S. Mail, FedEx, or UPS using your account number or ours (shipping costs will be added to your invoice). *Due to the extra packaging required, jobs sent via FedEx, UPS or USPS will incur a handling charge of \$5 per package within the U.S., and \$15 per package for international shipments.*

**Our cut-off time for shipping is 2:30 pm**

**We must have enough time to process, image and package your job before 2:30 pm for our scheduled pickup.** *If your turnaround is critical, but too tight for the route pickup, we may be able to drop your package directly at the depot - the cut off for the depot is 3:45 pm. You may be charged an additional fee for this service.*

## fine print

- Complete, accurate instructions must accompany your file. We are not responsible for misunderstandings or delays caused by missing or incomplete information.
- We prefer high resolution pdf files, with fonts embedded, for imaging film, plates or proofs. We support native files created in Adobe formats (InDesign, Illustrator, Photoshop). If you submit native files, please include all supporting files, graphics and fonts. We cannot accept native files in Microsoft Word, Excel, Publisher or PowerPoint - please send high resolution pdfs for these programs.
- **Published prices are based on standard turnaround time.** Normally that means a 24-hour turn (8 business hours). Most of the time we are much faster than that, and as a general rule we do not charge rush fees if we can accommodate your deadline. We are open Monday-Friday, 7am-4pm. We are closed on major holidays and weekends, but we are willing to work with you if you have a deadline - please call to find out if someone will be available to help. *Service on weekends, holidays and after regular business hours may incur overtime charges.*
- Payment is due at time of service unless credit terms have been established. On established accounts, payment is **due 30 days** from the **invoice date**. Reminder statements are sent around the 3rd of each month. We can accept credit cards, but we will charge you a credit card fee in addition to your invoice amount (currently around 3.4% + 50¢).
- Every attempt is made to make sure your files are correctly imaged. If Delta Graphics has made an error, we are responsible only for the cost of material replacement of film, plates or proofs. You should carefully inspect all materials when they are received and notify us within five working days if there is a problem with the output. You are responsible for proofreading files typeset by Delta Graphics, including, but not limited to: addresses, phone numbers, spelling, and color breaks. By approving artwork you are accepting responsibility for any errors contained within. We are never responsible for printing costs or other losses incurred by incorrect or faulty materials, regardless of error.
